Questions:

- 1. Please explain how current education policies for national autonomous regions, including "Bilingual Education," "Bilingual Pre-school Education," and "Ethnic Mingling" (e.g., decisions of the September 2014 National Conference on Ethnic Work) are consistent with the provisions for minority language use in China's Constitution.
- 2. Please explain why China has not complied with several key requirements of the United Nations Convention on the Rights of the Child and the recommendations of the Committee on the Rights of the Child.
- 3. Please explain why China has not addressed the concerns of the UN Committee on the Elimination of All Forms of Racial Discrimination expressed in 2018, particularly that, "Tibetan language teaching in schools in the [TAR] has not been placed on an equal footing in law, policy and practice with Chinese, and that it has been significantly restricted."
- 4. In numerous recent official statements, "social stability" appears to be considered a higher priority than ensuring the rights of minorities to mother tongue instruction. Please explain how this is consistent with domestic and international legal standards.
